## Rotherham demo, 25 February 2017

### Media briefing



The English Defence League is coming to Rotherham on 25 February to highlight:

#### 1. Local issues:

- Rotherham's Muslims try to divert attention from the 1,400 abuse victims P 1
- The Marxist left align with Rotherham's Muslims for the left's advantage
- Slow progress in the investigations into alleged police misconduct linked to Rotherham child sex crimes P 3
- The cover-up by the Muslim community of Rotherham's Muslim grooming and abuse gangs P 3
- The failure of Rotherham Council to take seriously the cataclysm revealed by the Jay report and subsequent Crown Court trials P 4

#### 2. National issues:

This year we will demonstrate in England's hot-spots of Islamification and in Muslim-controlled "no-go areas" to give heart to English people who, until the Brexit referendum, felt ignored and who have been intimidated into not expressing their heartfelt fears for their nation's future and the society in which their children will grow up.

#### The history:

On 5 September 2015 there were two demonstrations in Rotherham:

- a patriot group protesting about Muslim grooming of English girls by mainly Muslim Pakistani men
- a "Muslim Lives Matter" demonstration arranged by left-wing political groups to oppose the patriots, and stoke Muslim grievances.

After the patriots' demonstration some of their number went to a friendly pub, the William Fry on Wellgate. *South Yorkshire Police channelled the anti-patriot group who were on Wellgate past the William Fry.* The patriots let the new arrivals know their views and the latter - fired up by the left-wing protest - turned the confrontation physical by hurling a wheelie bin at the pub entrance. This can be seen on YouTube. A handful of patriots

emerged from the William Fry and a clash ensued. The police arrested a number of men from each side.

### **The outcomes - before the trial:**

**A boycott of South Yorkshire Police** - In October 2015 A group of Rotherham Muslim men and “British Muslim Youth” began a boycott of South Yorkshire Police and any Muslim businesses that cooperated with the police.

**Establishing a protest panel** - In April 2016 the South Yorkshire Police and Crime Commissioner established an “Independent Advisory Panel for Minority Communities”, twelve of whose thirteen members are Muslims. The panel has a number of stated roles, but their headline function is, according to the BBC, to be a “protest panel”.

• **EDL says:** *Previous demonstrations by the English Defence League and Britain First have been peaceful (except to the extent they have been disrupted by our opponents). We would, therefore, expect to see the panel demonstrate its impartiality by recommending:*

- *that EDL and BF demonstrations proceed as requested, and*
- *that anti-EDL/BF protests be policed for what they are: as the prime threat to the community, to free speech, to businesses and the ability of Rotherham to recover its reputation*

**The out-of-town Left use the trial** - In the lead up to the November 2016 trial, stirrers from the left exploited the Pakistani Muslim community by siding with them for what the left could get out of it. “The Monitoring Group” from London helped publicise the trial, organised the defence and captured the post trial publicity.

### **The outcomes from the trial:**

**Muslims acquitted** - The trial of 12 anti-patriots was held at Sheffield Crown Court in November 2016 and ten were acquitted. The remaining two had earlier pleaded guilty, but, in the light of the others’ acquittals, they were permitted to change their pleas to not guilty. One of this pair had just been released from prison for violent offences.

• **EDL asks:** *Why were the two allowed to change their pleas?*

**The Left exploit the acquittal** - The left exploited the Rotherham Muslims and goaded them by making a triumphal statement on their behalf outside the court. The Muslims were not permitted to make their statement themselves. Instead, Suresh Grover, director of “The Monitoring Group”, said their anger was directed at the patriot groups, South Yorkshire Police and the Crown Prosecution Service.

• **EDL says:** *This whole charade is a shabby and contemptible attempt to direct attention away from the past and present victims of Rotherham’s grooming/abuse gangs and toward the non-problem of English people expressing outrage at the Rotherham scandal.*

**The local left are also involved** - Phil Turner from the Rotherham Advertiser has a conflict of interest due to his involvement with the Socialist Workers’ Party and his role in coordinating UAF and Antifa opposition to this EDL demo. The Advertiser’s coverage is therefore predictable - and it will exclude all or most of the issues in this briefing - the very rationale for our demo.

• **EDL says:** *Watch out for “fake news” from the Rotherham Advertiser!*

## What of the South Yorkshire Police?

The previous management left SYP in a hole. The new management is turning the force around, but middle management must shake off their culture of edgy tolerance and even chumminess with unsavoury members of the local Muslim community.

- **EDL asks:** *Was it this chumminess that led to the Pakistani thugs being directed to the William Fry in Wellgate by SYP?*
- **EDL says:** *SYP appear to be bending over backwards to cuddle up to members of the Muslim community as a whole. Yet it is many of these ordinary everyday Rotherham Muslims who are holding back justice for the 1,400 victims by withholding information. If all Rotherham's Muslims came clean with all they know, the vast majority of those subject to the 100 live investigations would be charged and awaiting trial.*

With the help of the National Crime Agency, a few prosecutions are proceeding and the backlog is gradually being dislodged.

- **EDL says:** *Of the 1,400 victims, less than 2% have seen their abusers in court!*

## Slow progress in the investigations into alleged police misconduct linked to Rotherham child sex crimes

The police (SYP and IPCC) still have to deal with 56 investigations into alleged police misconduct linked to Rotherham child sex crimes. The IPCC has received complaints against 92 named police officers.

- **EDL says:** *All these investigations should proceed, even where the accused police officers have transferred, retired or moved overseas.*

## The cover-up by the Muslim community of Rotherham's Muslim grooming and abuse gangs

**The Muslim community's contempt for English justice and their English victims** - We get a feeling for the arrogance and cruelty of the Muslim community from the reports of the recent sentencing of a Rotherham grooming/abuse gang.

- Two convicted Rotherham child abusers shouted the Muslim triumphalist cry "Allahu Akbar" as they were sentenced.
- The gang leader openly boasted that he was racist and told his 13-year-old white victim: 'All white girls are good for is sex and they are just sl\*gs.'
- The rapists and abusers showed no emotion as they were jailed. Sageer Hussain appeared to smirk as he was led away.
- The judge said one man had conducted a "campaign of violent rape" against the vulnerable girl. "She was targeted, sexualised and subjected to acts of a degrading and violent nature. The childhood and adolescence of each of the victims can never be reclaimed."

**The Muslim community's cover up of their child abusers** – If accused men strut their arrogance like this in public, while in the dock, and their friends back them up just as openly, we can suspect that they boasted of their child sexual abuse far and wide. We find it easy to imagine that the abusers' parents, siblings, imams, workmates, business associates, community leaders, aunts, uncles and other acquaintances (including their children) *must* have been aware of it. As were the traffickers' clients who paid to abuse

the victims. But they all clammed up for the investigation. At the very least, they asked no questions and looked the other way to protect their own - even violent criminals.

**Breaking the Muslim community cover-up** - If there was no Muslim wall of silence, there would never - *could never* - have been 1,400 child sexual abuse victims in Rotherham.

### **Cover-up by Rotherham churches**

- **The churches in Rotherham have gone along with the cover-up.** Church leaders and members have been seduced by the pleasant Muslims they meet at “interfaith gatherings”, people they find so pleasant, they cannot bring themselves to hold them to account. But the time for meekness by Rotherham churches ended decades ago.  
As we have warned many times, child grooming should be seen as “rape jihad”, aimed specifically at the next generation of English mothers. Churches and church members who celebrate the institution of the family should see this Islamic strategy for what it is - and act as if the future of Western civilisation was at stake. *Because it is!*
- **If the Rotherham churches were worth their salt**, they’d be marching in the street. *But because they won’t, we will!*
- **If the Rotherham churches were worth their salt**, they’d be fully familiar with the deep misogyny in Islam. They would be calling local Islamic clerics to account for the way they preach about non-Muslim women in their sermons. They would demand that imams do not leave open the possibility that their congregations could interpret their words in ways that may lead to condoning abuse of English girls and covering up grooming when it does take place.

### **The failure of Rotherham Council to take seriously the cataclysm revealed by the Jay report and subsequent Crown Court trials**

Despite the numbers of cases (1,400 girls abused in Rotherham), the scale of the crimes has never been acknowledged in a way that conveys sincerity:

- Before the Jay report there was denial, neglect, bullying and cronyism
- After the Jay report the denial continued, self righteously:
  - Council leader, Roger Stone (Labour) resigned saying he would take full responsibility for "the historic failings". We never heard how he took responsibility - only that he ducked responsibility by jumping ship.
  - Council Chief Executive, Martin Kimber, said disdainfully that no Council officers would face disciplinary action.
  - The Council's director of children's services, Joyce Thacker, soon left the authority - and the country.
  - The Police and Crime Commissioner, Sean Wright, the most egregious denier, clung onto his position - despite calls to resign from the Home Secretary. He resigned four days after the EDL’s big 13 September demonstration in Rotherham.

## National issues

### The reluctance of police leadership outside South Yorkshire to match the progress beginning in Rotherham in investigating Muslim grooming and child abuse

South Yorkshire Police and the National Crime Agency appear to be making progress on the identified cases of Muslim child grooming and abuse in Rotherham.

Elsewhere in the country, the ducking and dodging which marked pre-Jay Report Rotherham still mark police operations. For example, the new initiatives designed to deal with child sexual exploitation focus on warning youngsters about online grooming and “sexting” rather than the more difficult and more serious long-term gang grooming.

We know that in Rotherham there are more than 100 investigations under way into more than 300 suspects and 9,000 lines of inquiry. We know none of this for the other centres of Muslim grooming gang operations.

The secrecy continues at Council levels, too. Last month, for example, Bradford Council refused to hold an inquiry into child sexual exploitation in Keighley, despite knowing how useful the Jay report was in kick-starting the turnaround in Rotherham.

• **EDL says:** *The cover-up of Muslim child sexual grooming and abuse continues and is one of its great enablers.*

### Two Royal Commissions are needed into Muslim grooming gangs

**Nothing less than two Royal Commissions** – Our nation and our future generations deserve *two* thorough inquiries into Muslim child grooming and sexual abuse, with Royal Commission powers to compel witnesses including those retired, even those overseas:

- One into the cover-up that abuse – by other Muslims as well as by government officials.
- Another into what motivates Muslim men to abuse English girls on an extraordinary scale.
  - This is not the EDL’s own idea. It comes straight from the Serious Case Review of the 2012 Oxford grooming gang investigation: *“With a significant proportion of those found guilty nationally of group CSE being from a Pakistani and/or Muslim heritage, relevant government departments should research why this is the case, in order to guide prevention strategies.”*

• **EDL asks:** *Why has this recommendation not been acted upon? Another cover-up!*

### The danger posed to the UK by our sentimentalism about people who deliberately break our laws to enter the country

**The UK is still recklessly welcoming refugees** – The latest fad is “child refugees”. And we don’t have to detail here the concern expressed across Britain that the “children” are mainly teenage boys and adults who are lying about their age. If they lie about their age, what else are they lying about? Could they be trained terrorists?

**There is no reason why the UK must accept refugees** - “Virtue signallers” want the UK to elbow its way to the front of the list of possible places of refuge. Even assuming that taking in refugees is best for the refugees, which it is not, before Britain is considered as their refuge (let alone as a permanent home), these countries should take millions first: Saudi Arabia, the Gulf states, Iran, Kazakhstan, Mongolia, Tibet, Russia, Japan, countries

of South America and, possibly, Angola, Mozambique, Zimbabwe and Tanzania.

England is the most densely populated nation in Europe and we have to protect our environment and infrastructure. And, when we consider the people in need here in England, we should remember we still have an obligation to assist them - first!
